### U15-U18 High School Premier Team Fees 2016/17

Parent/guardian information: Please keep this first page for your records

**The annual high school premier team fee is \$1050.** This includes:

All coaching and field rentals from November to July, team practices, OYSA fall league fees & games, OYSA State Cup or Presidents Cup Tournaments (April/May), team and coaching equipment, and club administration.

Summer tournaments have separate fees, which will be charged to participating players after each tournament. The separate tournament fees for Oregon and Washington tournaments are \$60-\$90. These tournament fees are due after the tournament occurs.

Uniforms are purchased at Direct Kick Soccer Shop, W. 11<sup>th</sup> Avenue in Eugene. Please see the uniform order sheet for prices and ordering information—visit Direct Kick for full information.

Full payment of the high school premier team fee is due by **March 15, 2017** unless a written request is made and approved for an alternative plan. A statement will be emailed to you monthly with your player's previous balance and that month's activity (payments, charges, credits). If you can't access email, let us know on the form below and we will mail a statement instead. If you have any questions about your statement, please contact the office using the contact information on the statement.

Payments in the following amounts are due on these dates unless you have an alternative payment plan. This is considered the standard payment plan:

August 20, 2016	\$200	initial deposit after tryouts or when a roster spot is offered
December 15, 2016	\$250	
January 15, 2017	\$200	
February 15, 2017	\$200	
March 15, 2017	\$200	

Please note: **tournament charges listed above will be added to your account for each tournament your player attends. Those tournament fees are due immediately when charged.**

#### Important Fee Policies:

-All accounts must be paid in full by **March 15, 2017** unless an alternative fee payment plan is approved. Eugene Timbers FC may not allow players to participate in games if their accounts are past due.

-Fees are non-refundable if a player chooses to leave a team or is injured, with exceptions determined on a case-by-case basis.
